A DAY IN THE LIFE Project Manager, Mike Williams

It's been seven years since I started work with Addington Fund and what a whirlwind of activity it has been in that time, from response to day to day maintenance and planned maintenance works, to the development of new dwellings in Cornwall and barn conversions in Cumbria.

Combining the above with meeting our existing and prospective tenants, towing the Addington Fund tractors, Jack and Jill, to various agricultural shows around the country, attending awards ceremonies and supporting the marketing and fundraising team makes my work very varied, and the Fund an exciting organisation to work for.

As we move rapidly into 2022, I am pleased to report that the new three bed detached dwelling at our Trevorra development in Probus, Cornwall, is nearing completion in readiness for occupation in May 2022.

Once the planning permission was obtained, we were able to move forward speedily with the development. We appointed Trevoran Homes as the main contractor, with whom we have had a great and now ongoing working relationship.

Similarly, we chose Mole Energy, an operating arm of Mole Valley Farmers, one of our main sponsors to provide what can only be described as a first class design and installation service of the solar photovoltaic panels with battery storage system and an electric vehicle charging point.

The new dwelling also has underfloor and hot water heating supplied by an air source heat pump, all of which helps Addington Fund become more sustainable and to meet the requirement to reduce its carbon footprint and reduce energy bills.

Recently, we have been fortunate enough to have been offered some exciting development opportunities in Lincolnshire and Leicestershire that we are currently investigating. In collaboration with the Duchy of

Cornwall and The Cornwall NFU Company Ltd we are also eagerly moving forward with an opportunity that has arisen at Nansledan near Newquay in Cornwall. This involves a proposal to provide six new affordable dwellings for eligible persons who meet our occupancy criteria. It is hoped that following the success of this

development, similar developments may be replicated around the country.

We are also investigating the possibility of providing further work/live units at our other development in Cornwall, to enable small startup agricultural/rural businesses to flourish. We hope to link these to small parcels of land.

Throughout England and Wales we continue to provide housing opportunities to meet the needs of farmers leaving the industry, in either shared or wholly owned Addington Fund housing within our retirement housing scheme, as well as affordable housing for rural workers.

The Addington Fund, as an independent charity, is able to be creative in its approach to the provision of housing. We are able to offer housing support and solutions and welcome the opportunity to discuss individual circumstances and to investigate any possible development opportunities with like-minded partners.

I am looking forward to further opportunities coming our way in 2022, helping people in need of housing and in raising yet further, the profile of Addington Fund.

Q) What are you looking forward to the most this year at the Devon Farm Business Awards and why is it important to support this event?

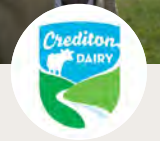
Q) How would you describe the Devon Farm Business Awards to someone who was looking to come on board and support the event?

Brand new three-bedroom home to rent near Probus, Cornwall

Our three bed, two storey, brand new detached home in a rural location near Probus will soon be available to rent. Monthly rent will be £650 for eligible persons, plus an annual service charge of approximately £450 per year. Priority will be given to potential tenants who meet the criteria of the charity; occupational

restrictions will apply. Tenancy for the chosen candidate begins the 1st May.

DEFRA Lump Sum Exit Scheme ...the detail and the Addington verdict

Last summer DEFRA announced their plan for a Lump Sum Exit scheme for farmers wishing to retire or leave the industry in a way that will open up opportunities for new entrants and farmers wishing to expand their businesses. This sounded like a radical idea and Addington eagerly awaited details of the scheme. In the meantime, it understandably put applications for our retirement houses on hold as potential applicants also waited to learn more.

In February 2022 the details were finally announced and the tax position was clarified. These details can be found on the government's website, and in a simpler, shorter version on a Defra blog.

It is proposed that:

- Farmers must have claimed BPS in 2018 or before to be eligible.
- The lump sum will be based on the average BPS payments made for the 2019-2021 years – this is the farmer's 'reference amount'.
- This reference amount will be capped at £42,500 and multiplied by 2.35 to calculate the lump sum. This means the maximum lump sum will be £99,875.

- Applications should be made between April 2022 until the end of September 2022, and farmers will have to transfer out their land by 31st May 2024 – apart from up to 5 hectares or land planted with trees under some woodland creation schemes.
- Lump sum payments will only be paid to the farmers when they have surrendered their English BPS entitlements.
- The amount is taxable under capital gains tax rules. In most cases this is likely to be 10%, but could be higher.
- Farmers surrendering their rights will be able to retain their farmhouse, other buildings and non-agricultural land.

Addington has given a cautious welcome to the announcement as it will give family farms an opportunity to retire a generation and restructure their businesses. We are disappointed by the level at which the cap is set, and as the sum is taxable we cannot see farmers opting for the scheme in large numbers. For those tenant farmers in the third generation of a three-generation tenancy or those who have no clear line of succession this might offer some encouragement but we do hope landlords will contribute as well if farmers do opt to take advantage of the exit scheme. Sadly, the recent increase in rural house prices will probably nullify any benefits for farmers who want to buy a retirement home locally. The Addington Fund will welcome applications from farmers who want to take up the exit scheme and retire if they need help with the purchase of a retirement home either in full or in a shared equity package.

Legacy Farm Scheme

Since Addington softly launched its legacy farm scheme to bring first generation farmers into the industry, we have received a great deal of interest from potential donors from across the country as well as prospective young entrants.

Our plan is to let farms that are bequeathed to us to first generation farmers who are agriculturally trained for affordable rents on long Farm Business Tenancies. Addington will engage the support and help of stakeholders including banks, land agents, agricultural merchants and other experts to help the new tenants succeed in their first step on the farming ladder.

The Addington Fund believes that first generation farmers or farmers who take on a great deal of responsibility early in life often turn out to be the best farmers as they tend to have a different attitude to risk and in their approach to new ventures. The average age of farmers rose from 57 to 59 last year and we believe it is important to bring new young blood into the industry with available support at the ready, and we are very excited by the scheme and what it can and will do for the industry.

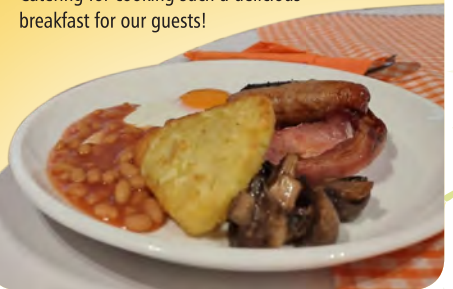
